

## 2019 Logan Center Sweepstakes Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR ODDS OF WINNING. VOID WHERE PROHIBITED.

All mailed entries must be postmarked no later than April 12, 2019, and must be received by UFCU by Friday, April 19, 2019, at 5:00 PM ET. All entries are the property of UFCU and will not be acknowledged or returned. UFCU is not responsible for entries that are lost, late, stolen, damaged, postage-due, undelivered, misdirected, returned, illegible or otherwise deficient, incomplete or not received for any reason. UFCU, in its sole discretion, reserves the right to disqualify any person tampering with the administration, security, proper play or entry process of this Sweepstakes or otherwise in violation of these Official Rules. UFCU further reserves the right to cancel, terminate or modify any promotion not capable of completion as planned, including, without limitation, by tampering, unauthorized intervention or force majeure.
- 2. Random Drawing:** One (1) Grand Prize winner will be selected by UFCU in a random drawing of all eligible entries received. The drawing will occur on or about April 23, 2019. Odds of winning will be determined by the number of eligible entries received by UFCU. Winner will be notified by telephone on or about April 22, 2019, at the phone number provided on the entry. The winner must provide UFCU with any information, including social security number, necessary to complete IRS Form 1099, and if the winner is not an owner of a UFCU Youth Savings account at the time of acceptance, necessary to open a Youth Savings account at the time the prize is accepted. The Grand Prize may be accepted by the winner at any UFCU branch or by calling 888-982-1400. Winner has 14 days from the day they are notified to accept the prize. Failure to complete prize acceptance or failure to comply with deadlines will result in forfeiture of prize. If a prize is forfeited, an alternate winner will be selected through subsequent drawing(s) of remaining entries until the prize is accepted. Prizes not accepted by May 31, 2019, will not be awarded.

Eligibility:** The Sweepstakes is open only to legal residents of the United States who (1) are 18 years or older as of April 1, 2019, (2) are the parent or guardian of a youth who is 20 years or younger as of April 1, 2019, and (3) are, or are eligible to become, UFCU members.
